Background

Arts Council England, the national development body for the sector in England, commissioned Euclid to identify EU funding for projects focused on or linked to the arts, museums and the creative industries in England across the last 10 years. EU funding works in 7 year cycles, so "the last 10 years" was interpreted as follows:

- The whole **7 years of the 2007-13 period**, for which (in theory) full information is available
- As much of the 2014-2020 period as could be ascertained at this time –
 2014-2016 being 3 years.

Types of EU Funding

EU funding can be split into two main **categories**:

- The European Structural & Investment Funds (ESIF), which are
 mostly devolved back to the member states and, in the case of the UK,
 then distributed separately in England, Scotland, Wales and NI. The
 ESIF also covers the Interreg programme which distributes funds via a
 number of geographically focused strands and sub-strands (England is
 eligible to participate in 6 of these).
- The **trans-national funds**, which are programmes designed to stimulate collaborative working between partners from several eligible countries, or to support visits and exchanges between countries.

Methodology

The research aimed to provide figures, with caveats, of the amount of funding the museums and galleries sector has received from the European Union in the last 10 years.

SOURCES

The starting point was to identify the **databases or downloadable lists of funded projects** that are provided by the European Commission (for Interreg and the trans-national funds) and by the **UK government** (for most of the Structural Funds: ERDF, ESF, EMFF/EFF) – **several hundred databases or schedules** were accessed in this way. For most of these databases, all projects with English partners were checked to see whether they were relevant to the sectors of interest. Other information was obtained from **reports** published by some of the **intermediary bodies** involved in these programmes – for example, by the various **Local Action Groups** (responsible for allocating the **LEADER** funds, part of the EAFRD).

KEYWORD SEARCHES

For some more extensive databases, the initial filtering was through **keyword searches**. For these, a number of key words used which were agreed with the commissioning body. For Arts Council England, the main agreed keywords were: **Art/s, Creativ*, Dance, Theatre, Music, Literature, Visual, Studio, Museum**. However, it is acknowledged that it is possible that a small number of projects may have been missed as a result of using these particular key words.

LIMITATIONS RE EAFRD, INCLUDING LEADER

For the vast bulk of the data gathered, enough information is available to be confident that the projects are indeed relevant to the sectors covered by Arts Council England, and the creative industries. However, for the EAFRD, the relevant bodies in England do not provide any overall online databases or listings of grants. It has been very difficult to obtain detailed information on specific grants from the EAFRD / RDPE / LEADER programmes and it is likely that the figures in this section are an underestimate.

Key Figures

The conclusion is that around 1385 projects received a minimum of £345m in EU funding in the period from 2007-2016. The total per year is approximately £40m – though this is a 10 year period, virtually no ESIF funds were allocated in 2014-15, so the total has been divided by 8.5.

Please note that these figures are subject to the caveats & notes as detailed above and at the bottom of this page.

There was a total of nearly £210m from the European Structural & Investment Funds, with the majority (£190m) from the ERDF (European Regional Development Fund). There was £13.5m from the ESF (European Social Fund), £5m from the EAFRD (European Agricultural Fund for Rural Development, including LEADER) and a small amount from the EMFF/EFF (the fisheries funds).

There was a total of around €164m (around £136m using the exchange rate at 1 January 2014 of €0.8298/£1) from Interreg and the transnational funds:

- The largest amount around €85m was from the 7th Framework research & development fund (€46.5m), and the subsequent programme, the Horizon 2020 programme (€39m).
- Around €29m (£24m) via the Interreg programme (part of the ESIF)
- Nearly €29m via the Culture (sub-)programme of Creative Europe, and its predecessor Culture programme.
- Around €20m via the Erasmus+ programme for education & training, and its predecessor programmes, Lifelong Learning and Youth in Action
- A small amount, around €50k from the Europe for Citizens programme, which focuses on projects related to the history of Europe and the EU, and on democratic engagement and civic participation

It is noted that the value of all this EU funding covers a **breadth of impacts** – from funding which has been of **specific benefit to the arts, museums & creative industries** in England, to **inward investment into English research institutions** (especially universities) who have a focus on related areas.

Estimated amounts for grants to individual partners

The only figures available for **Interreg** and most of the **trans-national** funds are for the total grant for the project, and not the amounts received by any individual partner. The exception is **Horizon 2020 / ERC / FP7**, where the grants to individual partners are available (in almost all cases).

The amounts transferred from the lead partner to the co-organiser partners can only be found by analysing the final financial statements of each and every individual project – this information is difficult, if not impossible, to access, and was not possible within the resources available for this research.

To address this issue, all the available information for these grants have been assessed and the **number of partners** for each project identified. The project grant was **divided by the number of partners** to get an estimate for the grant to each partner. In some cases, the actual figure will be more, in some cases, less.

This would appear to be an appropriate means of calculating a reasonably accurate estimate. The number of partners (and the number of English partners) are noted in the tables for these programmes in the Appendix.



- the **creative industries** had the most funding (by some way), followed by **music and museums**
- **ERDF** programme (mainly for regeneration): the **creative industries** has had the most (by some way), followed by **museums** and **theatre**
- agriculture and rural funding: the most was for museums and then for general arts & culture, followed by visual arts.
- Interreg, the most went to creative industries, followed by museums
- Re research funding, the most was in music, followed by literature and museums
- Re education, training and youth, both arts & culture and creative industries have done well, followed by museums and music
- For the **culture** programme itself, general **arts & culture**, **music**, **theatre** and the **visual arts** have done well





- London has been the most successful region London & the South East together have 30% of total funding followed by Yorkshire & Humberside
- For the **ESF** fund, the most has gone to the **West Midlands**, closely followed by **London**
- For agriculture and fisheries, the most has gone to the South West and then the North East
- For **Interreg**, the most has gone to the **South East, East of England** and **South West** this reflects the fact that the only eligible areas for Interreg A are these 3 regions.
- For the **Culture** programme, the most successful region is **London** by far
- For education, training and youth, the most successful region is London again, by far
- For research, it is once again London, followed by the South East

- The largest average grants, by far, are for the ERDF programme
- The smallest average grants are for the Youth in Action programme, followed by EMFF and Europe for Citizens, and then the EAFRD
- Within **Interreg**, the average grants vary across the various strands
- Of the trans-national funds, the largest average grants are from FP7 / Horizon 2020 programmes
- There is a large drop to the next highest average, from the **Culture / Creative Europe** programmes
- All other trans-national funds provide an average grant per partner between £5-30K
